Rules: All entries must be cooked on the official cook-off grounds. Each team will need to bring at least 10 lbs of beef. Burgers should be between 6 and 8 oz. Each team is responsible for any other condiment they would like to use. The contestant is responsible for observing accepted and prudent temperature and sanitary requirements. Contestants cannot sell samples to the general public.
